

Terms and conditions

The Competition is run by Funkypigeon.com Limited, (company number 06208854) County Gates, Ashton Road, Bristol, BS3 2JH, UK (the “**Promoter**”).

By entering this competition, all entrants will be deemed to have accepted the following terms and conditions (the “**Terms**”). The Promoter reserves the right to refuse entries, or refuse to award any prize to anyone in breach of these Terms.

Entry Method and Requirements

1. The competition will open at 9am GMT on 12th March 2020 and ends at midnight on 22nd March 2020. Entries submitted after this time will not be accepted.
2. To enter, entrants must add an event reminder to their Funky Pigeon account through the portal on the competition page - www.funkypigeon.com/pages/competitionlanding.aspx. Any other event reminders added to the customer’s account outside of the specified competition page will not be counted as an entry towards the competition. Reminders added as part of the competition will be used to remind the customer of upcoming events.
